Inspector of Prisons Investigation Report

- 1. The deceased was an 83 year old man who resided in the Leinster area.
- 2. The deceased was committed to prison on 2 December 2016, with a remission date of 19 April 2019.
- 3. I wrote to the next of kin of the deceased but they did not wish to meet. I can understand their position.
- 4. I was informed that the deceased suffered from a number of chronic medical conditions and that his medical needs could not be managed in prison.
- 5. On 8 December 2016 the deceased was admitted to Portlaoise General Hospital, through the A & E Department. He remained an in-patient of Portlaoise General Hospital until 28 February 2017.
- The deceased was granted reviewable temporary release on 28 February 2017 on compassionate grounds. He was transferred to a Nursing Home in the Leinster area.
- 7. The deceased satisfied the terms of his reviewable temporary release.
- 8. The deceased lived in the Nursing Home until his death on 27 January 2018.

Findings

- 9. The deceased was released on Reviewable Temporary Release, which was subject to a number of conditions, on 28 February 2017. I am satisfied that the granting of Reviewable Temporary Release to the deceased was appropriate, having regard to his medical condition.
- 10. The deceased satisfied the terms of his reviewable temporary release.
- 11. The cause of death is a matter for the Coroner.
- 12. I am satisfied there are no significant matters that require further investigation.
